#### INTRODUCTION

The Institute of Trichologists holds and promotes a register or trichologists who have attained educational qualifications to practice as an IOT Trichologist. Registration to the Institute of Trichologists runs from the 1<sup>st</sup> July to 30<sup>th</sup> June of the following year each year. The registration renewal process runs from the start of June each year, with registrations being required to be renewed before the registration start date of 1<sup>st</sup> July. The renewal date deadline is the 30<sup>th</sup> June.

## 1. MAINTAINING REGISTRANT STATUS

Trichologists who wish to remain on the register for the upcoming registration year need to complete and submit our renewal form, and pay the annual fee to stay on the register. The renewal form is to confirm they are fit to practice, and informs us whether they have, for example, any disciplinary matters with other regulators, health issues or criminal convictions that we should be aware of.

Additionally, registrants must agree to the following declarations:

- I have read and understood, and agree to abide by the Articles of Association
- I have read and understood, and agree to abide by the Code of Professional Practice and Ethics
- I will provide the IOT within 7 days of any and all details if I receive a sanction from a professional body e.g. General Medical Council (GMC); or if I am subject of a regulatory investigation; if I am suspended, dismissed, refused membership or placed under a practice restriction following concerns about my professional conduct or competence by another organisation (including regulator, insurer, professional body, employer).
- I agree to inform the IOT within 7 days if have received a police charge, if I am charged
  with a criminal offence, convicted of a criminal offence, accepted a caution, reprimand,
  warning, Fixed Penalty Notice or Penalty Notice for Disorder, or a similar measure in the
  UK or abroad.



• I will declare to the IOT details of any physical or mental health condition that may impair my fitness to practise as a registered IOT Trichologist.

#### 1.1 REGISTRATION RENEWAL PROCESS

- 1. On 1<sup>st</sup> June, all registrants will be contacted via the Institute of Trichologists
  Administration team, where they will be given any necessary information, and provided access to annual registration forms and fee payment on the registrant portal.
- 2. Registrants must complete the renewal form and make payment for their annual registration fees by 30<sup>th</sup> June.

### 1.2 REQUIRED SUPPORTING DOCUMENTS

The following supporting documents / information are required to be submitted as part of the renewal forms:

- Business Insurance Certificates, unless retired or not currently practicing Trichology
- Proof of Information Commissioner's Office registration (as required by UK law)

#### 2. FAILURE TO RENEW REGISTRATION

Registrants of the Institute of Trichologists are required to renew their membership by the 30<sup>th</sup> June each year. If a registrant misses the deadline:

We will you with a final warning notice before the deadline of 30 June, which gives you a further 30 days (up until 30 July) to fill in the form and pay the fee. If renewal is not complete by the 31 July, your registration will lapse and you will no longer be registered with the Institute of Trichologists.
